Dear PTACH Parents:

It is hard to believe that this school year is half over, and we must already plan for the next school year. The ATT remains committed to ensuring PTACH's growth and continued success. We recognize that tuition is a major expense for all families in the ATT system and have not raised tuition for the past three years. However, PTACH's programming and services create a large budget and maximizing its tuition income is critical in sustaining a quality program. Therefore, PTACH tuition for the 2016-2017 school year will be \$16,000. Each family's Give or Get obligation remains at \$1500.00 (which many PTACH families easily obtain through their involvement in the Annual PTACH Fundraiser).

Enclosed are three forms that need to be completed and returned by Wednesday, May 4, 2016:


1. The first form is the **PTACH Re-Enrollment Application**. This form must be returned to the ATT office with a \$100.00 non-refundable deposit per child.
2. The second form is a one-page Financial Survey. This form must be returned to the ATT office.
3. The third form, the **FACTS Grant & Aid Application (FACTS)** form, is optional. This form must be completed in order to receive any type of scholarship. It can either be completed using the enclosed hard copy or online. The FACTS PTACH ID# is 21307.
  - a. If using a hard copy, please note that you must call FACTS at 866-315-9262 to orally complete a set of questions not on the hard copy. Your application will not be processed until this is done. These questions are included in the mailing so you can prepare your answers before calling. This paper application must be returned in the enclosed FACTS envelope to FACTS.
  - b. If completing online, please go to <https://online.factsmgt.com/signin/42748>. Please remember after completing the online application, you will still need to mail or fax the supporting documentation to FACTS in order for your application to be complete.


